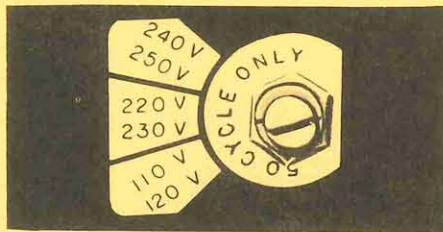

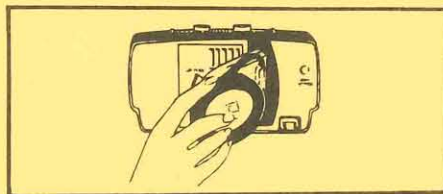
## Model 260 Super 8 INSTANT MOVIE PROJECTOR

**NOTE: THIS MODEL  
DESIGNED FOR  
OPERATION ON 50  
CYCLE CURRENT ONLY.**

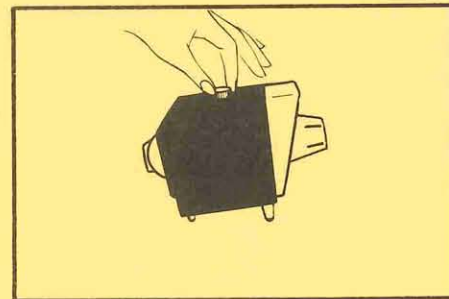
### SET-UP AND OPERATION



1. Set selector switch, located on bottom of projector, to the proper 50 cycle voltage source available; 110-120 V, 220-230 V or 240-250 V. Place the projector on a firm, level table or surface with lens pointed toward screen. Plug power cord into electrical outlet. Be sure no obstructions block free flow of air at front and rear of projector.



2. Insert Super 8 Magi-Cartridge containing your film into the cartridge slot in rear of projector. Be sure words "Super 8" imprinted on the plastic cartridge are upright and the arrows point toward the projector. The small rail along the bottom edge of cartridge fits into groove at bottom of cartridge slot. (Cartridge lock-out prevents accidental use of std. 8mm film cartridge).



3. Turn the control switch (on top of projector) to the "on" position, and the show is on — instantly! Turn the control switch "off" at the end of the film story, otherwise film will continue to repeat until projector is switched off. Always be sure to turn the projector "off" before removing cartridge.

### FOCUS AND FRAMING

To center picture vertically on the screen, adjust projector height with geared tilt control knob. Center picture by moving (sliding) the projector to either side.

To focus the picture, rotate the lens barrel to the right or left.

To adjust picture to fit the screen size, move the projector toward or away from screen — or on models equipped with zoom lens, simply slide the zoom lens in or out.

To adjust picture framing, turn framing knob on top of the projector.

The film in the projector will run continuously until you turn the projector off.

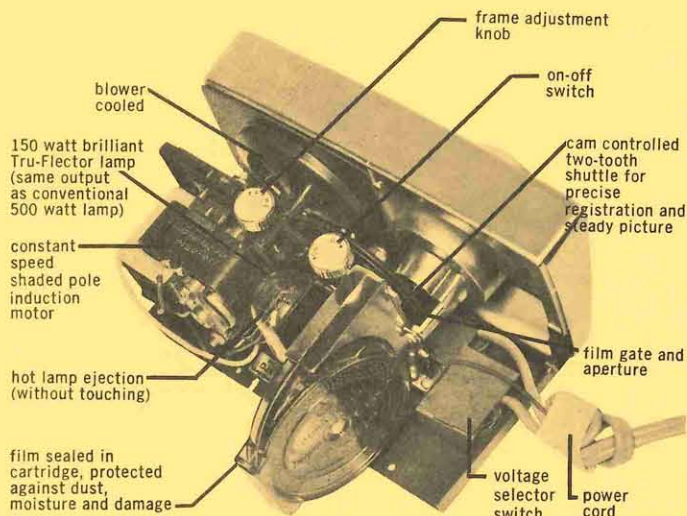
**NOTE:** For longer film life, do not run any individual cartridge continuously for more than four (4) showings.

Keep front and rear of projector clear of obstructions which might prevent free circulation of cooling air.

**MAINTENANCE:** No oiling is necessary. The Technicolor Instant Movie Projector is lubricated for life.

**CLEANING THE APERTURE:** If your picture becomes fuzzy or uneven around the edge, use a camel's hair brush or pipe cleaner to clean the film gate and aperture. If a pipe cleaner is used, bend the end so that wire is not exposed. **Be sure projector is turned off when cleaning the aperture.**

**CLEANING THE LENS:** Unscrew lens and pull straight out. Wipe both ends with dry, lintless cloth. Replace.

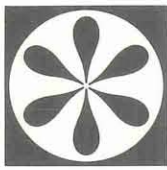


**REPLACING THE LAMP:** Unplug power cord. Turn projector upside down and follow these instructions shown on special plate:

1. Loosen two screws and remove rear cover.
2. Push small pointed object against bulb stem until bulb pops out.
3. Rotate new bulb until stem key fits socket. Press in firmly.

**NOTE:** FOR BEST PERFORMANCE FROM YOUR PROJECTOR, A "DJA" PROJECTION LAMP SHOULD BE USED AS REPLACEMENT.
